#### 4. NEW PASS BRIDGE RESOLUTION (75-36)

At the direction of the Commission resolution No. 75-36 was read, supporting the efforts of the Sarasota County Commission in requesting that the Department of Transportation start construction of a new New Pass Bridge in the 1977-1978 fiscal with addition in Section 1 of , "Chairman, Sarasota County Commission" after Larry to the Sarasota County Commission.

#### 5. BUDGET AMENDING ORDINANCE (75-24)

At the direction of the Commission, Ordinance No. 75-24 was placed on first reading by title only, amending the budget for fiscal year October 1, 1975 - September 30, 1976. Mayor Kenney explained this budget amendment was being made in order to make renovations to four lift stations at the south end of the Key acquired as part of the sewer system. ### 6. CODIFICATION ADOPTING ORDINANCE (75-20)

At the direction of the Commission, Ordinance No. 75-20 adopting a revision and codification of the Town Code, was placed on second reading by title only. Town Attorney Whitesell explained this adopts a codification done by the Municipal Code Corporation of all ordinances from the time of last codification through February 5, 1975. Also, it readopts all State statutes concerning traffic control and adopts declared the public Infractions Acts. Pursuant to published notice, Mayor Kenney It was moved by Gibbon, seconded by Sedwick that the ordinance be passed on second aye; Ridyard, aye; Sedwick, aye; Kenney, aye.

# 7. SARASOTA COUNTY RESOLUTION SUPPORT AUTHORIZED

The Commission had discussed at work session a resolution by Sarasota County calling for a comprehensive investigation by the Pollution Control Board of phosphate mining in south Florida. It was moved by McCall, seconded by Gibbon that the Mayor be authorized to write a letter to Sarasota County supporting their action. Motion carried unanimously.

# 8. BICENTENNIAL COMMITTEE DONATION AUTHORIZED

As discussed at the previous day's workshop session, it was moved by Edmundson, seconded by Sedwick that a donation of \$250 be authorized for operating expenses of the Bicentennial Committee. Motion carried unanimously.
