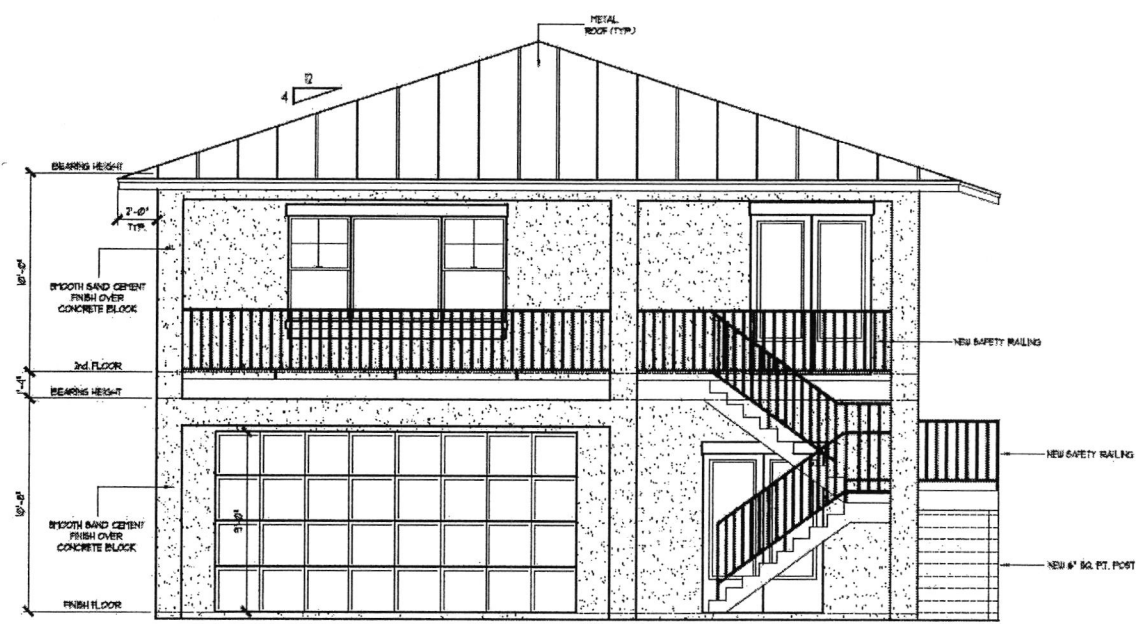

Photo One Caption FRONT

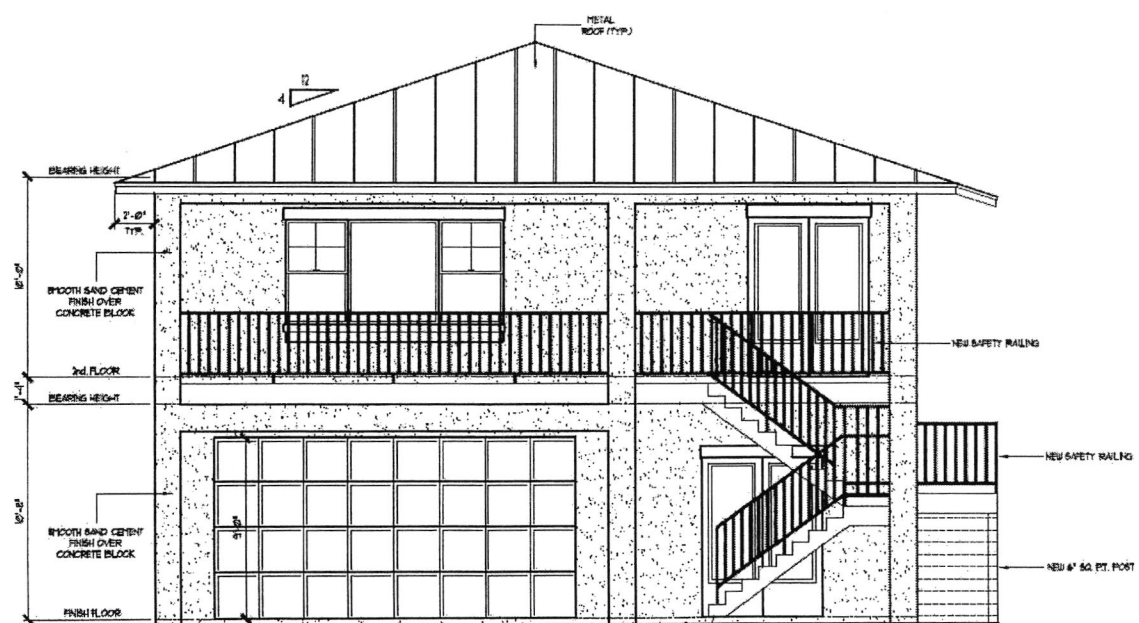

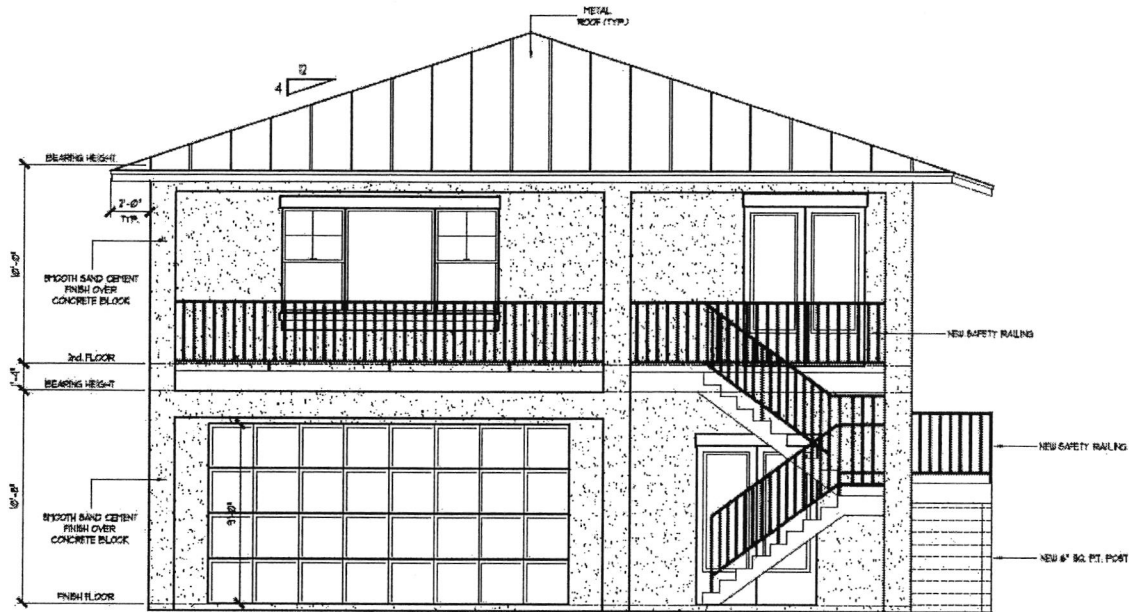

Photo One Caption WEST SIDE

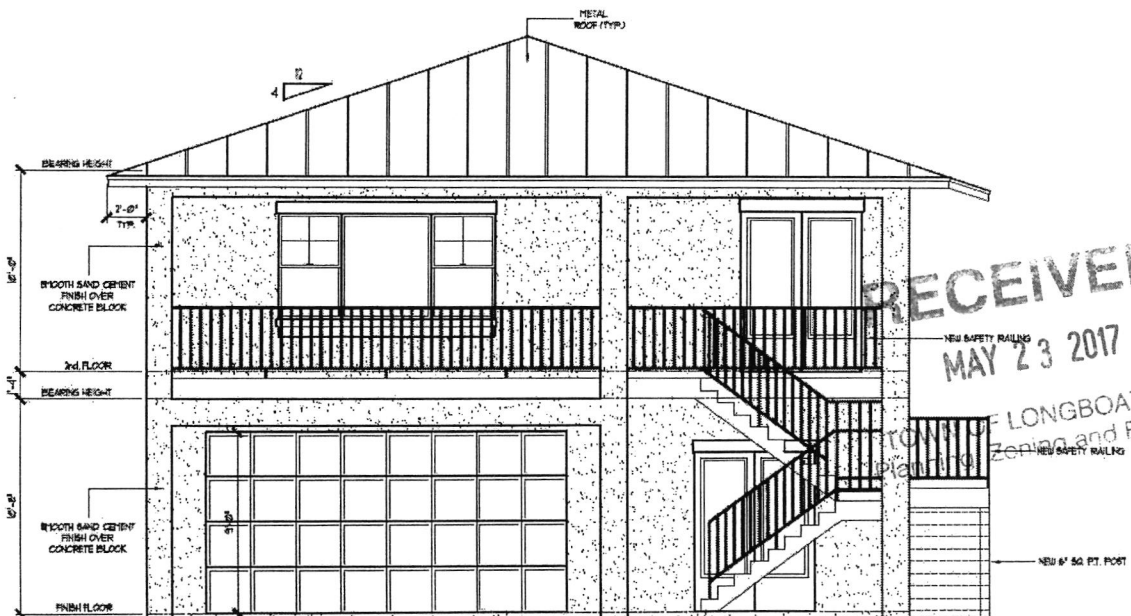
