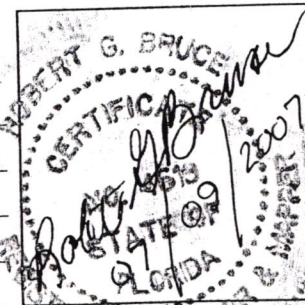

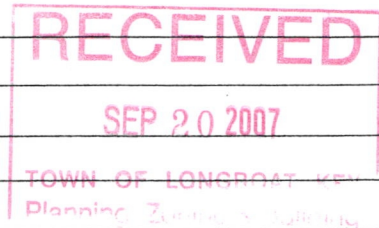

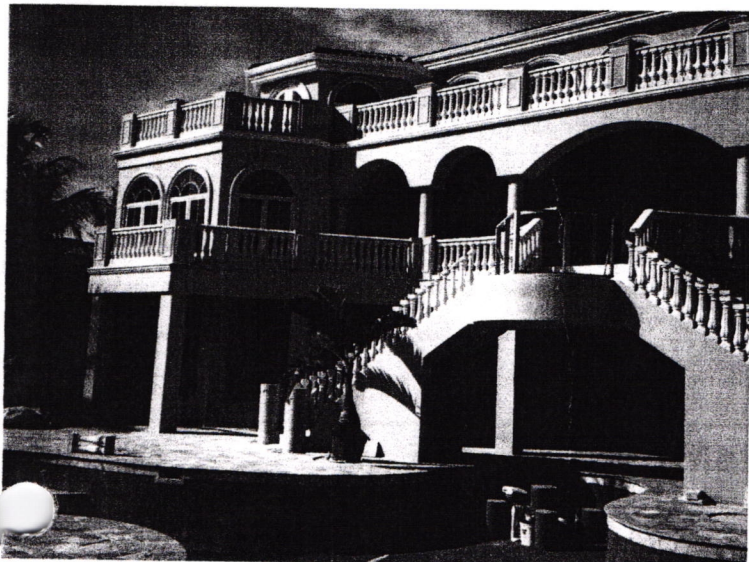
FRONT VIEW
