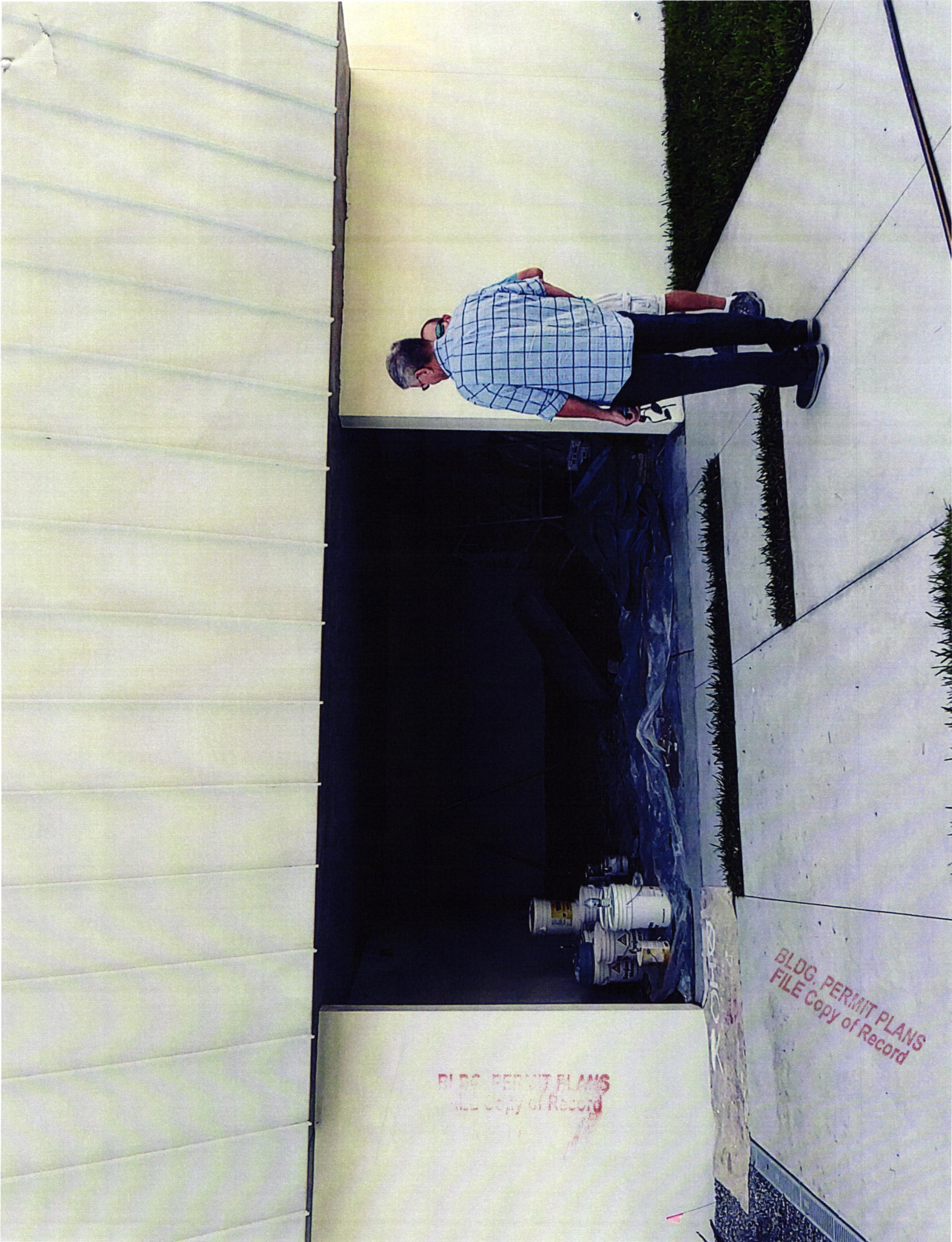
Building Diagrams
