Town staff (PZB, Fire Dept. & North Port Fire Dept.) completed a windshield survey damage assessment of all Town streets this afternoon. Thankfully, overall no noticeable structural, windows or roof damage was seen. This report will be shared with Damage Assessments teams in Sarasota Co. & Manatee Co.

A number of streets, which experienced flooding, may have had structures with water intrusion. The structures with observed water levels at, exceeding or with visible water level markings are identified below. In addition to the structures below, based on personal eyewitness reports, the Gulf Shore Mobile Home Park & the Twin Shores Mobile Home Park had an undetermined number of units that experienced water damage in the structures and a larger number were reported to have had damaging water levels to exterior air conditioning and water heater units. The receded water levels & lack of water level markings made accurate estimates unreliable at this time.
