CONDITIONS REQUISITE FOR APPROVAL FOR ABBONDANZA! DELICATESSEN (TOWN PLAZA) AVENUE OF THE FLOWERS AMENDED SITE PLAN REVIEW January 5, 1987

- 1. The number of tables shall be limited to four and no more than 16 chairs shall be permitted.
- 2. Placement of the tables and chairs shall be restricted to the 266 square foot area shown on the site sketch.
- 3. Full pedestrian access shall be maintained between the seating area and Abbondanza! Deli and along the adjacent covered corridor. At no time shall the tables or chairs be placed so as to block entry or exit from the restaurant.
- 4. The total square footage of Bay Isles Commercial Center shall not exceed 127,064 square feet including the 266 square feet approved for outdoor seating.
- 5. All necessary outside agency permits shall be obtained.
- 6. A guard rail or some type of barrier acceptable to the Town, shall be built along the existing planter immediately west of the seating area, in accordance with the specifications of the Town Building Department.
- 7. The provisions of the site plan application package dated October 23, 1986 and received on the same date, for the subject property, shall be complied with unless waived or modified by the above conditions or by agreement between the Town and the applicant or amended pursuant to the code.
- 8. All work stated in these conditions shall be completed before the Town will permit the use of the proposed seatin $\boldsymbol{\varsigma}$
