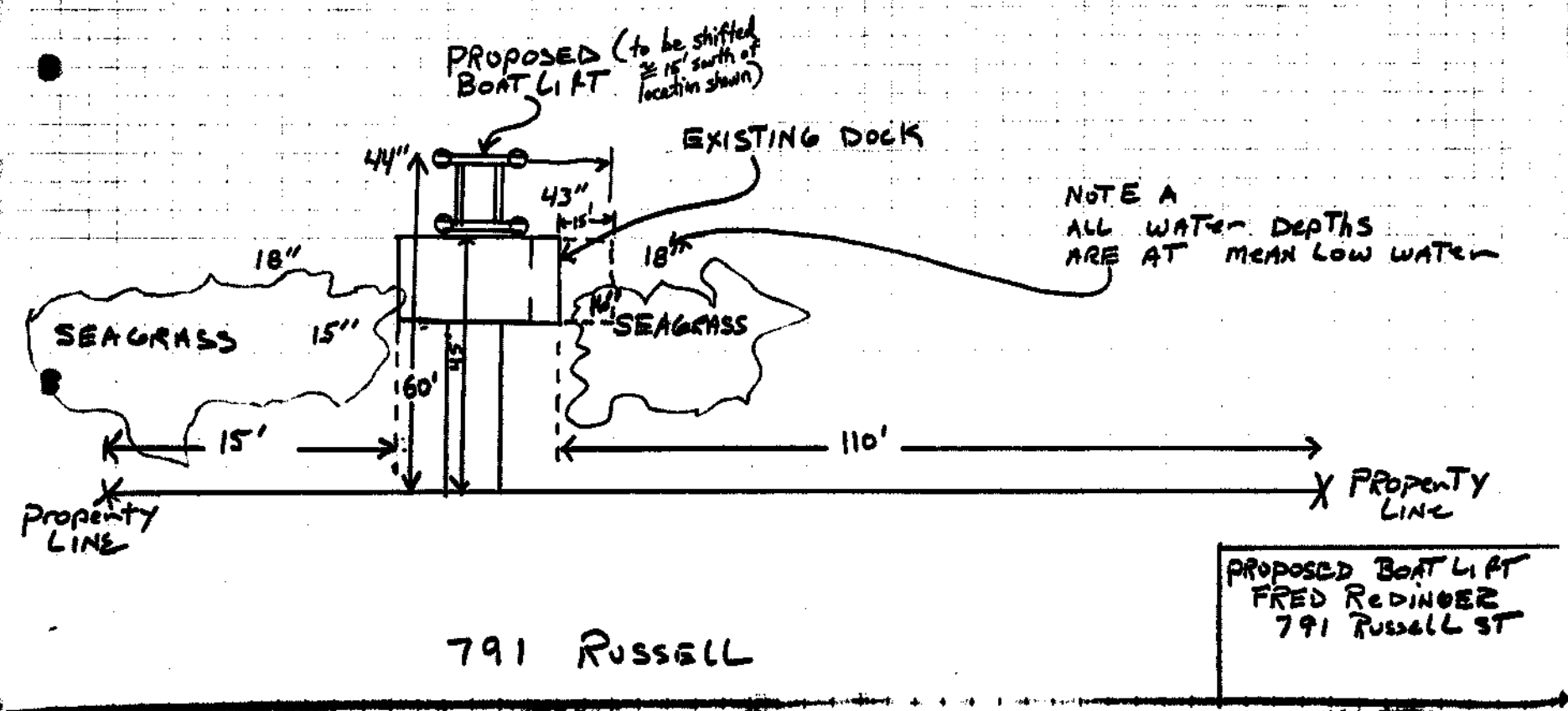

ZONING DISTRICT: R-6SF: Single-family (6 du/a)
REQUEST: Town Code Section 158.155 (3) limits the length of a piling, dock, or boatlift to thirty (30') feet beyond the Mean High Water Line (MHWL). The applicant is petitioning the Board for a variance from this section of the Code as a means to construct a boatlift which is located at the end of an existing dock located 61 ft. from the MHWL, and to extend the existing dock laterally 15 ft.

STAFF ASSESSMENT:

1. The variance is in fact a variance as set forth within this Chapter and within the jurisdiction of the Board (reference: Town Attorney's comments and Zoning Code, Section 158.155 (A) (3)).
2. Special conditions and circumstances do exist which are peculiar to the land, structure, or building and which are not applicable to other lands, structures, or buildings in the same zoning district.
3. The special conditions and circumstances do not result from the actions of the applicant.
4. Granting the variance requested will not confer on the applicant special privilege that is denied by this chapter to other lands, buildings or structures in the same zoning district.
5. Literal interpretation of the provisions of this chapter would deprive the applicant of rights commonly enjoyed by other properties in the same zoning district under the terms of this chapter and would result in unnecessary and undue hardship on the applicant.

6. The variance, if granted, is the minimum variance that will make possible the reasonable use of the land, building or structure.
7. The grant of the variance will be in harmony with the general intent and purpose of this chapter.

STAFF SUMMARY:

Due to shallow water depth, the existing dock is located beyond the 30 ft. length which the Code currently allows. The shallow water depth at this location also precludes the placement of a boatlift at a length of 30 ft. Construction of a boatlift at a length of 30 ft. would also adversely impact upon the bay bottom and seagrasses. As noted in the variance petition, the applicant has completed a review of the waterway adjacent to the property to determine the optimum location for placement of the boatlift. Based upon the results of this review, extending the existing dock laterally 15 ft. to the south, and thus constructing the boatlift 15 ft. more to the south would ensure that the neighbor on the north side would not be affected by the new boatlift. As such, the location and length proposed by the applicant reflects that which would have the least impact upon the environment and would not impede navigable access to adjacent lots.

Based upon staff's assessment of this petition relative to applicable variance criteria, the hardship is caused by special conditions which are peculiar to the property (mainly water depth and seagrasses). Grant of this variance would not provide special privilege, but rather would allow for reasonable use of the property. Survey results noted in the application indicate that this is the minimum variance that will make possible the reasonable use of the land, and staff would recommend APPROVAL of Variance Petition #10-92.

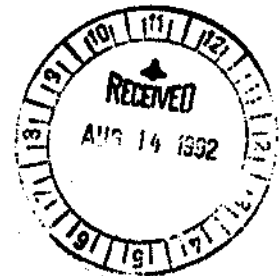

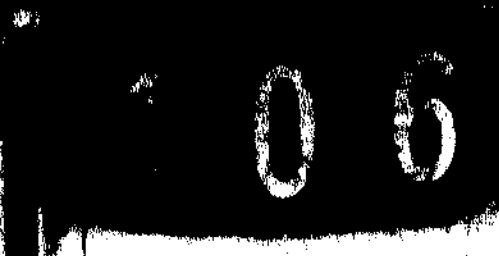
