SUBJECT: Legislative Priorities

At the September 22, 2011 Regular Workshop Meeting the Commission considered establishing legislative priorities for the upcoming 2011-2012 legislative session.

There was consensus to forward the following issues to the October 3, 2011 Regular Meeting for formal action:

1. Support amendment to 163.3167(12) to provide for glitch language allowing local governments to retain certain referenda processes related to land use planning that were in place as of June 1, 2011.
2. Oppose legislation that allows oil drilling off the West coast of Florida.
3. Support State funding for research, control, and mitigation of Red Tide.
4. Support State funding for beach nourishment.
5. Support State authorization of other revenue sources beyond our present sources.
6. Oppose unfunded mandates on local governments.
7. Support reform on the method of tax assessments on non-homesteaded and commercial properties including capping annual increases.

For other presentations, you must provide fifteen (15) copies of your material on 3-hole punched paper (it is not necessary for you to provide presentation binders). You or your group will be placed on the agenda (after local bill presentations) in the order that we receive your information. We will not know the final order of presentation until 48 hours before the meeting.

According to the rules of the Manatee County Legislative Delegation, presentation materials in their entirety must be made available to members of the delegation at least 48 hours prior to the meeting. This is to provide individual members with adequate time to review your material and prepare any questions. In order to meet this deadline, please ensure that your complete presentation materials are received in my office at 3653 Cortez Road West (Wildewood Professional Park), Suite 90, Bradenton, FL 34210, **no later than 5:00 p.m. on Thursday October 20, 2011. Any materials received after this deadline will not be included in the delegation notebooks and you will NOT be placed on the agenda. You will still be welcome to speak but will be required to fill out a card for public speaking and be heard at the end of the completed agenda (in order received). THERE WILL BE NO EXCEPTIONS TO THIS DEADLINE.**
