SUBJECT: Legislative Priorities

Each year the legislative delegations for Manatee and Sarasota Counties ask the community for input regarding their legislative priorities for the upcoming year. In the past these issues have been considered by the Town Commission at a Regular Workshop Meeting then forwarded to a Regular Meeting for formal action.

The Sarasota County Legislative Delegation requested that the Town forward the Commission's legislative priorities by September 12, for consideration at their September 18, 2013 Legislative Delegation Meeting and Public Hearing. I have attached a proposed list of legislative issues for your consideration. For your reference, I have included the Commission-approved priorities submitted to Manasota League, Sarasota County and Manatee County identifying Longboat Key's 2012-2013 legislative priorities.

The County-sponsored Legislative Delegation Meetings are not the only opportunity the Town has to present information to the legislative delegation. In fact, if the Town has a serious concern about any particular issue it is recommended that a more directed lobbying effort be made.

The Sarasota County Board of County Commissioners will take formal action on their proposed legislative priorities at their September 11, 2013 meeting. The Manatee County Legislative Delegation Meeting is scheduled for December 4, 2013; therefore, the Manatee County legislative priorities will be developed later in the Fall.

SUBJECT: Legislative Priorities

At the September 3, 2013 Regular Meeting the Town Commission will adopt legislative priorities for 2013-2014. A list of proposed legislative issues for the upcoming legislative delegation meetings was forwarded from the September 3, 2013 Special Meeting.

2013-2014 Town of Longboat Key Legislative Priorities (Not in Order of Priority)

Proposed 2013-2014 Priority

1. Support for Legislative action to address unintended consequences of Florida House Bills 537 and 7019, Growth Management, regarding the Local Government's ability to conduct referendum processes relating to Development Orders, Comprehensive Plan Amendments, or Map Amendments. (Draft language amending Subsection (8) of Section 163.3167, Florida Statutes is attached.)

PROPOSED DRAFT AS OF 8/14/2013

Section 1. Subsection (8) of section 163.3167, Florida Statutes, is amended to read:

163.3167 Scope of act.

(8) (a) An initiative or referendum process in regard to any development order is prohibited.

(b) An initiative or referendum process in regard to any local comprehensive plan amendment or map amendment is prohibited. However, an initiative or referendum process in regard to any local comprehensive plan amendment or map amendment ~~that affects more than five parcels of land~~ is allowed if it is expressly authorized by specific language in a local government charter that was lawful and in effect on June 1, 2011; a general local government charter provision for an initiative or referendum process is not sufficient.

(c) It is the intent of the Legislature that initiative and referendum be prohibited in regard to any development order. It is the intent of the Legislature that initiative and referendum be prohibited in regard to any local comprehensive plan or map amendment, except as specifically and narrowly permitted in paragraph (b) ~~with regard to local comprehensive plan or map amendments that affect more than five parcels of land~~. Therefore, the prohibition on initiative and referendum stated in paragraphs (a) and (b) is remedial in nature and applies retroactively to any initiative or referendum process commenced after June 1, 2011, and any such initiative or referendum process that has been commenced or completed thereafter is hereby deemed null and void and of no legal force and effect.

Section 2. This act shall take effect upon becoming a law.






