Re: BP Oil Spill Litigation -- TIME SENSITIVE / URGENT ATTENTION REQUIRED

Dear Mr. Bullock,

This letter is to address our recommended next step regarding your BP oil spill claim.

As you are aware, we filed an Oil Pollution Act ("OPA") Presentment Claim on behalf of Town of Longboat Key on January 18, 2013. That OPA Presentment Claim was filed to preserve your rights to proceed against BP America Production Co. and BP Exploration & Production, Inc., and BP p.l.c. ("BP") for the losses incurred as a result of the *Deepwater Horizon* Oil Spill. The OPA Presentment Claim filing not only placed BP on notice of your claim for damages, but also was intended to satisfy a pre-suit requirement under the OPA statute.

By law, BP was given 90 days from the date of the filing to respond to the demand made in the OPA Presentment Claim. Ninety days will soon pass, and we have not yet received a response from BP. As a result, we recommend proceeding with a lawsuit against BP. We also recommend including claims against the Transocean and Halliburton entities who may be potentially liable for damages from the oil spill in the lawsuit.

As some read the Oil Pollution Act to require that any litigation arising out of or resulting from the BP oil spill to be brought within three years of the date of the spill began, or in this case April 20, 2010, the date of the initial blowout and explosions onboard the *Deepwater Horizon*, we are preparing to file suit for all of our OPA Presentment clients by April 19, 2013. Before doing so, however, we of course need written authorization from you to file such a lawsuit.


